AN ORDINANCE OF THE TOWN OF MCINTYRE, GEORGIA, AMENDING CHAPTER 31 OF THE CODE OF ORDINANCES RELATING TO DRINKING IN PUBLIC.

THE MAYOR AND COUNCIL OF THE TOWN OF MCINTYRE HEREBY FINDS THAT IT IS NECESSARY FOR THE SAFETY AND WELL BEING OF THE CITIZENS OF THE TOWN FOR THE TOWN TO PROVIDE AN ORDINANCE PROHIBITING THE DRINKING IN PUBLIC OF BEER OR OTHER MALT BEVERAGES, WINE OR OTHER ALCOHOLIC BEVERAGES, OR THE POSSESSION OR DISPLAY OF SUCH BEVERAGES IN OPEN CONTAINERS WITHIN THE TOWN LIMITS OF MCINTYRE.

PURSUANT TO THE AUTHORITY OF SECTION 2.7 OF THE CHARTER OF THE TOWN OF MCINTYRE AND IT IS ORDAINED, BY THE MAYOR AND COUNCIL OF THE TOWN OF MCINTYRE, GEORGIA, BY AUTHORITY OF SAME, THAT:

SECTION 1: CHAPTER 31 (GENERAL OFFENSES) OF THE CODE OF ORDINANCES OF THE TOWN OF MCINTYRE IS HEREBY AMENDED BY ADDING A NEW SECTION, DESIGNATED AS SECTION 31-111, TO READ AS FOLLOWS:

"SECTION 31-111: CONSUMPTION OF ALCOHOLIC BEVERAGES:

- (1) IT SHALL BE UNLAWFUL FOR ANY PERSON TO DRINK BEER OR OTHER MALT BEVERAGES, WINE, OR ANY OTHER ALCOHOLIC BEVERAGE, OR POSSESS SUCH ALCOHOLIC BEVERAGES IN ANY OPEN CONTAINER WHILE UPON OR WITHIN ANY PARKED VEHICLE, UPON OR IN ANY PUBLIC STREET, ALLEY, PARKING LOT, PARK OR CITY OWNED OR OPERATED RECREATION FACILITY, PUBLIC BUILDING OR ANY PARKING AREA ADJACENT TO ANY PLACE OF BUSINESS OPEN TO THE PUBLIC.
- (2) IT SHALL BE UNLAWFUL FOR ANY PERSON TO CARRY, DRINK OR POSSESS ANY BEER OR OTHER MALT BEVERAGE, WINE OR OTHER ALCOHOLIC BEVERAGE IN ANY TYPE OF OPEN CONTAINER, BOTTLE, CUP, GLASS OR CAN, WHILE UPON OR IN ANY PUBLIC STREET, SIDEWALK, ALLEY, PARKING LOT, CITY OWNED OR OPERATED RECREATIONAL FACILITY OR ANY PARKING AREA ADJACENT TO ANY PLACE OF BUSINESS OPEN TO THE PUBLIC.
- SECTION 2: ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT WITH THIS ORDINANCE ARE HEREBY REPEALED.
- SECTION 3: IF ANY PORTION OF THIS ORDINANCE SHALL BE HELD TO
 BE INVALID OR UNCONSTITUTIONAL, SUCH INVALIDITY
 OR UNCONSTITUTIONALITY SHALL NOT AFFECT OR IMPAIR
 THE REMAINING PORTIONS UNLESS IT CLEARLY APPEARS
 THAT SUCH OTHER PARTS ARE WHOLLY AND NECESSARILY
 DEPENDENT UPON THE PART HELD TO BE INVALID OR

UNCONSTITUTIONAL.

- SECTION 4: THE RECORDER'S COURT OF THE TOWN OF MCINTYRE SHALL HAVE JURISDICTION OF ANY OFFENSE PROSECUTED UNDER THIS SECTION.
- SECTION 5: THIS ORDINANCE SHALL BECOME EFFECTIVE UPON ITS READING AND PASSAGE AS PROVIDED IN THE TOWN CHARTER.
- SECTION 6: IT IS THE INTENT OF THE MAYOR AND COUNCIL AND IT IS ENACTED THAT THE PROVISIONS OF THIS ORDINANCE SHALL BECOME AND BE MADE A PART OF THE CODE OF ORDINANCES OF THE TOWN OF MCINTYRE, GEORGIA, AND THAT SECTIONS OF THIS ORDINANCE BE RENUMBERED OR RELETTERED TO ACCOMPLISH SUCH INTENTION.
